Data collected automatically when visiting our website

Our website uses Google Analytics, a web analytics service offered by Google Inc. (hereinafter referred to as "Google"). Google Analytics uses cookies which are saved on your computer to facilitate analysis of your website use. The information collected relates to your operating system, browser and IP address, the website you accessed previously (referrer URL), and the date and time of your visit to our website. The information generated by cookies regarding your use of our website typically is transmitted to and saved on a Google server in the United States.
